Introduction

This form is intended to clarify submission requirements and does not need to be submitted to DMCC. Established in 1963, Dun & Bradstreet's Data Universal Numbering System, commonly known as the D-U-N-S Number, is a unique global business identification system that identifies, validates, and links to more than 240 million businesses worldwide.

The D-U-N-S Number is a nine-digit non-indicative numbering sequence and is assigned at the lowest organizational level, i.e. business locations with a unique, separate, and distinct operation. In UAE, DUNS number is issued exclusively by Dun & Bradstreet's local partner CRIF Gulf DWC LLC (CRIF). DMCC licensed companies can request for DUNS number through DMCC Member Portal.

Services to Select on DMCC Member Portal

Go to Value Added Services - DUNS Number

Steps

- 1. Log on to the company's portal account, click on Value Added Services menu and then click on DUNS Number service request.
- 2. Fill in the fields with your license number, email address and contact details and save.
- 3. Finally submit the service request to proceed.

Policy

- DMCC licensed companies can request online for D-U-N-S number if they have at least one active license.
- The D-U-N-S number is issued at the company level, which means that companies with multiple licenses will have the same D-U-N-S number.
- In order to process the application for DUNS Number, DMCC will share the following information
 of the applicant company with Dun & Bradstreet UAE (CRIF Gulf DWC LLC):
 - Company Name
 - Primary Email Address
 - Primary Contact Number
